IV. Eligibility

Applicants should have completed 17 years of age as on the 31st December 2024. No relaxation in the minimum age will be allowed. There is no upper age limit

Candidates who have passed Higher Secondary Examination, Kerala, or Examinations recognized as equivalent thereto, with **Physics** and **Mathematics** as compulsory subjects and **Chemistry** as one of the optional subjects with at least **45% marks put together** in the above subjects are eligible for admission. In case, the candidate has not studied Chemistry, the marks obtained in Computer Science shall be considered. In case, the candidate has not studied Chemistry and Computer Science the marks obtained in Biotechnology shall be considered. In case, the candidate has not studied Chemistry, Computer Science and Biotechnology the marks obtained in Biology shall be considered. The marks as shown in the mark list of the Board of Examination obtained from the respective Higher Secondary Board shall be considered for academic eligibility. Candidates belonging to SC/ST/ SEBC or PwD the minimum mark obtained in Physics, Mathematics, Chemistry/Computer Science/ Biotechnology/Biology taken together in qualifying examination shall be 40% instead of 45%

- d. Selected and confirming candidates have to remit the fee in the College on or before the last date published in the college website to confirm their seats and failure to do so will lead to cancellation of admission and provide the seat to the next ranked candidate.

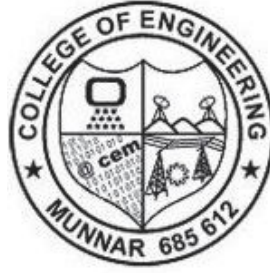
